I. Checklist for Voluntary Return

Before the Return

The returnee should

- √ bring diplomas/ certificates and other relevant official documents obtained from schools in Germany.
- ✓ obtain apostille (legalization) from the Embassy of the Republic of Azerbaijan for the birth certificate/s of newborn children.
- ✓ receive information concerning the arrival at the airport and the onward journey. There is a direct express minibus route number 116 operating from the airport to Baku city center. Service runs every 30 minutes starting from early in the morning until late at night. The bus leaves outside the airport building, across the parking area. The service terminates at Samed Vurgun Park on the 28th May Street. The journey from the city center to the airport takes approximately 30-40 min. The journey from the city center to the airport by car takes approximately 30 min-40 min. Taxis in Baku are the purple London cabs. To use the service of "London" taxis, it is enough to call Baku Taxi Company short code *9000. Other convenient twenty-fourhour taxi services are provided by "Motor Service" Company (99412) 189, "Salamtaksi" *9933 which receives the orders by calls 24/7.
- ✓ take vaccinations certificate/s from clinics/ hospitals that will be necessary when returning to the country of origin for the (re-)registration in public hospitals, especially for children.
- √ find a temporary accommodation.

After the Return

The returnee should

- ✓ apply for documents at the State Agency for Public Service and Social Innovations under the President of the Republic of Azerbaijan (ASAN) (http://www.asan.gov.az/),
- ✓ if you travel with a re-entry certificate (i.e. laissez-passer) and your national ID or passport is expired. Otherwise, there is no mandatory registration upon arrival.
- ✓ re-check the registration in a public hospital near to the residing area.
- √ targeted social assistance is provided by the government to low-income families, if applicable.
- ✓ approach the State Employment Service under the Ministry of Labor and Social Protection of Population for the possible employment purpose.
- contact the services assisting with the search for jobs and housing.
- √ apply for childcare, schools or other educational institutions.

II. Health Care (1/2)

I. **General Information**

Mandatory Health Insurance:

The State Agency on Mandatory Health Insurance implements the mandatory health insurance through accumulating revenues to finance medical services within benefit package and acting as purchaser of these services.

Mandatory health insurance (MHI) has been implemented as a pilot scheme in Mingachevir, Yevlakh, and Aghash providing 1829 medical services within a benefit package.

The list of medical services included in the benefit package and their prices were approved by the Decree of the President of the Republic of Azerbaijan No.1181 by December 28, 2016. The total number of medical services covered by the benefit package of MHI, which are applicable in the administrative areas Mingachevir city, Yevlakh and Aghdash districts, is 1829: Primary healthcare - 18, First aid and emergency medical care – 6, Outpatient service – 480, Inpatient services – 677, Laboratory services – 459, Physiotherapy services – 23, Vital and important expensive medical services -166.

Rights and responsibilities of the insured person:

- In the event of an occurrence, to receive health care services included in the benefit in accordance with procedure package specified by Law of the Republic of Azerbaijan "On Medical Insurance";
- to choose a healthcare provider or medical territorial unit that has a contract with the State Agency on Mandatory Health Insurance for financing of health care services;
- to request from the health care provider the submission of credible information about the type, period, volume, quality and conditions of the health care services delivered by the healthcare provider or medical territorial unit:

- to request not to reveal information constituting a doctor-patient confidentiality under the Law of the Republic of Azerbaijan on "Protection of Population Health";
- to claim compensation from healthcare provider or medical territorial unit for the damage caused by healthcare provider or medical territorial unit:
- to apply to the State Agency on Mandatory Health Insurance or to the court for the protection of the legitimate rights and interests regarding to the mandatory health insurance:
- to receive information about insurance premiums paid for the insured persons;
- to request from the State Agency on Mandatory Health Insurance for an explanation of the rights and responsibilities about the mandatory health insurance;
- to require insurer (employer) to cover them under mandatory health insurance as well as make payment of insurance premiums on time and in full.

- Duties of the insured person:
 If necessary, inform the health care provider or medical territorial unit about the state of their health:
- To present an identity card while approaching to healthcare provider or medical territorial unit.

II. Health Care (2/2)

Benefits:

According to the Law of the Republic of Azerbaijan "On Public Health Care" (or Code on the Protection of Public Health) No. 360-IQ by June 26, 1997, the medical services should be free of charge at state-owned hospitals and care units. In Azerbaijan, the Ministry of Health (MoH) is responsible for the healthcare system.

Most medical facilities, which include public hospitals, as well as pediatric and adult polyclinics, are state-owned and services are free of charge. Polyclinics offer outpatient services only, while hospitals and specialized clinics offer both outpatient and inpatient services. Private medical establishments are growing very rapidly; while they are licensed by the Ministry of Health, they are otherwise independent.

Some medical treatments, for example oncology, can be obtained at state hospitals only. Reproductive health and maternity services are offered at women's consultation centers.

Procedure of admission:

There is no special unit available that returnees should approach for further referral. First, they need to visit a nearby hospital/clinic according to their place of residence.

Availability and costs of medications:

A manual on essential drug use has been published and distributed by the MoH. Drugs are purchased and distributed to hospitals by the Pharmaceutical Department of the MoH. free-of-charge Drugs are for inpatient treatments. Patients are charged for the drugs for outpatient treatments, except for cancer and some psychiatric illnesses. Drugs are relatively expensive. Most drugs are available, but some may not be found in Azerbaijan. In some cases, the names may be different from those in the EU. Pharmacies are usually private. Health Care System: Access for Returnees

Eligibility and requirements: All public clinic/hospitals are free of charge with a valid national ID

Registration procedure: Returnees need to contact the Ministry of Health or a nearby hospital/ clinic according to their place of registration.

Required documents: Valid National ID

III. Labour Market and Employment

I. General information

One of the main trends of the socio-economic policy realized in the Republic of Azerbaijan during the last years is development of labor market and advantageous use of the labor force.

The reforms implemented in the country, which were caused by the change of the fundamental quality of the country's economy, have enabled dynamic economic development. Relevant measures were taken to improve the regional economic development, as well as to increase the social welfare and the quality of life of the population in the regions, by specifically carrying out further development of the non-oil sector.

According to the Order of the President of Azerbaijan, minimum monthly wage has been increased from 180 manats up to 250 manats.

2. Ways/assistance to find employment

The State Employment Agency under the Ministry of Labor and Social Protection of Population provides assistance on employment.

3. Unemployment assistance

General information on public and/or private unemployment assistance:

The Unemployment Insurance Fund began operating in Azerbaijan in 2018. The budget of the Azerbaijan State Social Protection Fund and the Unemployment Insurance Fund has been submitted for discussion at the plenary meeting of the Azerbaijani Parliament. The revenues of the Unemployment Insurance Fund for 2019 are projected at 98.451 million manats.

Benefits and Costs:

Insured persons whose employment is terminated as a result of the liquidation of a public body or a legal entity, or a reduction in the number of employees and registered as an unemployed in the State Employment Agency shall be entitled to unemployment insurance.

4. Further education and training

Vocational training of job seekers and unemployed people registered in the employment centers shall be provided by the State Employment Agency in the following cases:

- when job seekers and unemployed persons are not able to choose suitable employment for them due to the lack of the necessary profession or specialty;
- if the job seeker or unemployed person loses the ability to work in the previous occupation.

Professional training of unemployed persons is organized by the State Employment Agency for free. Job seekers are involved in vocational training on a paid basis.

IV. Housing

L. General Information

The rental costs for an apartment in the capital city vary depending on the location, ranging from 300 AZN per month to 600 AZN and more. Apartments can be rented based on an agreement certified by a public notary. The fee for this notary action is 23 AZN and the returnee's valid nation ID is required.

3. Social grants for housing

According to the Decree of the President of the Republic of Azerbaijan on "Forming of mortgage loans systems in the Republic of Azerbaijan" No.299, by 16 September 2005, the Azerbaijan Mortgage Fund under the National Bank of the Republic of Azerbaijan was established to improve the living conditions of the population, build an efficient housing finance mechanism, adapting to the supply with real demand and attract local and foreign investors to mortgage lending.

V. Social Welfare (1/2)

I. General Information

Social allowances are defined and paid in the form of monthly or one-time payments in order to provide social assistance to certain categories of persons.

Unless otherwise provided by international treaties to which Azerbaijan is a party, stateless persons and foreigners permanently residing in the territory of the Republic of Azerbaijan shall have the right to receive monthly and one-time benefits on the terms and in the manner prescribed by the respective Law for citizens of the Republic of Azerbaijan.

Allowances:

- Pregnancy and birth allowance;
- One-time allowance for the birth of a child;
- Allowance for low-income families with children up to I year;
- Childcare benefits up to the age of 3;
- Benefits for women with more than five children:
- Age allowance;
- Disability allowance;
- Social benefits to children under the age of 18 with disabilities;
- Allowance for the loss of a breadwinner;
- Monthly allowance for martyrs' children under the age of 16 (for students enrolled in public schools under the age of 18);
- Monthly allowance for children of military servants under the age of 16 (for students enrolled in public schools under the age of 18);
- Monthly allowance for children of persons disable in war and during January 20th events under the age of 16 (for students enrolled in public schools under the age of 18);
- Allowance for guardians of children who have lost their parents or lost their parental care;
- One-time treatment allowance for victims of radiation accident;

- One-time funeral allowance:
- One-time allowance for persons released from punishment and in need of social adaptation;
- Lifelong allowance for civil servants;
- Allowance for utilities, transportation and other services for children who have lost their parents or lost parental care;
- Allowance for utilities, transportation and other services to members of the martyr's family.

Eligibility:

- citizens of the Republic of Azerbaijan
- stateless persons and foreigners permanently residing in Azerbaijan

Costs:

There is no legal fee for receiving the necessary documentations for the respective allowance.

Benefits:

The amount of allowance is determined by the relevant state executive agency depending on the status and situation of the applicant and is subject to indexation at least once in a year (article 8 of the b/m law). Allowances are monthly or single paid, depending on the situation (article I of the a/m law).

Targeted state social assistance:

Targeted social assistance (TSA) is monthly subsidies, which are provided by the state to low-income families. TSA is provided for a period of 2 years starting from the month when the application is received. Low-income families have the right to apply for social assistance several times.

Low-income families, whose average monthly income is below the basic poverty threshold for each family member (160 manats are currently eligible) for reasons beyond their control, are eligible for the TSA.

V. Social Welfare (2/2)

2. Pension System

Pensions of the citizens of the Republic of Azerbaijan, as well as for foreigners and stateless persons permanently residing on the territory of the Republic of Azerbaijan, shall be appointed and paid according to the Law on Labor Pensions on equal terms with the citizens of the Republic of Azerbaijan.

The minimum labor pension is set at 200,00 manats.

Starting from the July 1, 2017 till July 1, 2021 for males and starting from July 1, 2017 till July 1, 2027 for females, the age limit is increasing for 6 month each year. From July 1, 2020 till June 30, 2021 the age limit for retirement is 65 and 62 for males and females, respectively. By July 1, 2026 the age limit for both gender groups will be 65.

There are 3 types of labor pensions:

- old-age labor pension
- disability labor pension
- survivor's labor pension

Old-age and disability labor pensions consist of 3 parts: basic part, insurance part, state funded part. For more information: State Social Protection Fund http://dsmf.gov.az

Costs:

The pension insurance is calculated in conformity with the calendar (days, months, years) and depends on the period of employment of the applicants/beneficiaries.

Access:

The preconditions for obtaining a pension are:

- women who have reached the age of 60 when resigning from work;
- men who have reached the age of 63 when resigning from work are entitled to obtain a pension if they have 5 years of insurance record;
- women aged from 44 to 51 who bring up 3 or more children or disabled children;
- male headed households aged above 55;
- guardianship of underage abandoned children or orphans.

identity documents, written application, labor records, other documents requested by the relevant executive agency.

VI. Education System

L. General Information

The state secures the right to compulsory general secondary education for each citizen. Every student enrolled in the public education institutions enjoys the right to free-of-charge general education. The state sets forth the right to receive a one-time free-of-charge education at secondary vocational-professional education level and at each level of higher education.

The languages of instruction are Russian, English and Azerbaijani. There are 4443 functioning preschool institutions, which serve 1567016 children of the respective age. 82% of preschool establishments for 1st year pupils are in urban localities. 5 special purpose and 5 sanatorium-type pre-schools are for physically or mentally disabled children to complement the general pre-school facilities. 6 pre-school establishments have special units where 404 children receive both education and treatment. 14 kindergartens accommodate special groups for deaf, blind and children with learning disabilities. There are 225 specialized schools, including 7 gymnasiums and 33 lyceums, which teach 84,000 high academic achievers.

2. Cost, loans and stipends

Depending on the test score achieved, applicants may be offered either a paid or state-funded education.

Access and requirements to higher education:

Students' admission to higher education institutions is carried out through competition by providing equal education opportunities for each citizen. Competent applicants, who have learned relevant educational programs that appropriate level of correspond to the education, are free to select their majors and education institutions by themselves. Winners of high-level contests and international science Olympiads are eligible to be admitted to higher education institutions without competition. Admission to higher education institutions are conducted by the State Examination Center of the Republic of Azerbaijan (SEC) according to the admission examination results.

Candidates are required to pay the fee for participation in the contest.

The Ministry of Education approves and verifies foreign diplomas only in conformity with bilateral agreements signed with other countries.

VII. Concrete Support for Returnees

The privileges of IDPs

In accordance with the respective law, the eviction of IDPs from the public buildings, flats, land allotments, and other objects where they were settled between 1992 and 1998 (not depending on the type of the ownership) is stopped until their return to their native homes or temporary resettlement place in new settlements or houses.

Additionally, heads of private education establishments, high and comprehensive study schools were recommended to provide assistance in employment of refugees and IDPs and also to consider concessions in payment of tuition fees.

Other privileges of IDPs:

- the IDP pupils in comprehensive schools are entitled for free textbooks;
- the IDPs have the priority right to keep their jobs on the occasion of redundancies or cuts in the offices, enterprises and organizations;
- the medications considered for free prescription by the Ministry of Health are paid for the IDPs by the state budget;
- they are entitled for free medical examination and treatment;
- they are free of charges when getting the citizenship IDPs;
- they are free of court charges when appealing to the courts;
- they are free of paying income tax for up to 55-fold of conditional financial unit;
- they are free of payment of notary charges when purchasing flats and residential houses.
